A note from leadership

Summarizing a year in the life of Compassion House is not as easy as one would think. It's not because there is nothing to report, nor is it because of some great change. As we have for over 20 years, Compassion House continues to offer exceptional supportive care for women who travel to Edmonton for cancer treatments.

In this report you will see the numbers and the impact of our activities over the past year. Those figures tell a story. 365 women, from 82 different communities spent the equivalent of nine years of nights at Sorretino's Compassion House. But the real story is the people who stay, work, volunteer, and support the House.

There really is no other place quite like Sorrentino's Compassion House. Women of all ages, from towns, from cities, from the far North, from diverse cultures and incredibly different life journeys bond over cancer treatments and instantly create a supportive community. Whether they are here for their first stay or their 10th follow up stay, these resilient women understand and support each other every time they cross the threshold of the door.

Our staff ensure that our inhouse programs are designed and delivered with the women we serve in mind. Every woman is unique and the staff never use a cookie cutter approach to service delivery. Their commitment to our guests is remarkable.

Rounding out our story are our volunteers and donors. Our volunteers provide services ranging from special event work, to playing the piano, to planting flowers, to teaching crafts, to driving the van. Their work adds to the joy that so many of our guests tell us they feel despite the reason for their stay.

Our donors and supporters play a significant role in our story. Sorrentino's Compassion House does not receive any government or ongoing funding from any source. It is no exaggeration to say, we couldn't do what we do without our donors. The individuals, corporations, service clubs, and foundations who donate to us ensure that we are able to provide a supportive and affordable housing option for women who may otherwise not be able to access their cancer treatments.

Our sincere thanks to everyone who was a part of our story this past year. All of you ensure that Sorrentino's Compassion House is more than a place to stay. It is a vital partner in the cancer journey for every woman who stays with us.


